Question One

Your friend Joe comes to you for legal advice. He tells you that when he was 25 years old he entered into a customary law marriage with his cousin Mary. At that time Mary was only 16 years old and she was forced into it by their parents. Due to this the dowry was paid while she was in Boarding School. When she came back home she was forced to move in with Joe. Their marriage was however not consummated due to a mutual agreement. She has since moved away from their matrimonial home and gone back to School. It is almost 2 years now and Joe wants to marry a girl that he met. He wants a church wedding.

- a) Using case law, Kenyan Constitution and the Marriage Act 2014, define a Marriage. (5 Marks)
- b) Advise Joe making sure to provide the general requirements of a marriage in Kenya. (20 Marks)

- a) Briefly discuss the role of the Registrar of marriages as per the Marriage Act 2014. (7 Marks)
- b) Explain the requirement for competent witnessing of a marriage under the Marriage Act 2014.
