## COURSE OUTLINE CRIMINAL PROCEDURE Prepared by Mr. Willis Otieno

This course is about the criminal trial process. At the end of the course, learners will be expected to understand the criminal trial process right from initiation of proceedings to the end of the criminal justice process. This will involve an appreciation of the various stages in the process including filing of a complaint, arrest, arraignment in court, charges and information, plea taking, bail and bond, the trial process, case to answer, judgment and sentencing.

A competent understanding of this course will require an appreciation of criminal law and its own processes. Criminal procedure is the due process through which an accused person is processes through the justice system to determine their guilt or otherwise. It aims to ensure justice to the accused persons and justice to the victims of the offence. Criminal law regulates offences while procedure regulates the process of accessing justice.

Main source of Criminal Procedure is the Criminal Procedure Code Cap 75 L.O.K. Learners will also make references to the Constitution and other Statutes regulating criminal conduct including the Penal Code Cap 6; the Anti Corruption and Economic Crimes Act (ACECA) on corruption and related crimes, the Proceeds of Crime and Anti Money Laundering Act on money laundering and related crimes, the Elections Act 2011 on election offences etc.
